Paper bags intended for contact with dry food, bakery products and fatty bakery products. Paper bags intended for contact with food have to be stored in clean, dry and ventilated storage. The storage time of paper bags is 24 months, provided that suitable storage conditions are observed. The ratio of the surface area in contact with the food is 6 dm<sup>2</sup> / 1 kg food.
